To accept our offer of a place, please return the enclosed Acceptance Form, along with the deposit of £2,500 by Monday 1st March 2021. Cheques should be made payable to Headington School and sent to The Registrar, Headington School, Oxford, OX3 7TD. Alternatively, if you would like to pay by bank transfer, our bank details are enclosed.

In addition to the Acceptance Form, I have enclosed a copy of our Terms and Conditions and the current schedule of fees. Our current Parent Handbook, which contains the school rules, code of conduct and policies, can be found <a href="here">here</a>. As stated in 1. (b) of the Terms and Conditions, the Offer and Acceptance Form constitute the terms of the contract between you and Headington School.

You should also be aware that if requires additional English lessons to support her studies, these would be charged in addition to the school fees.

## **Child Student Visas and Newland Chase Education**
