We would like to thank [REDACTED] for attending the interview morning on Saturday, 20 November 2021. The teachers enjoyed meeting him.

It is clear from the interviews and examination results that [REDACTED] is an intelligent young man with sound subject knowledge. He particularly impressed Mr Grant in his Art interview. We felt that given the opportunity to come to St Paul's he would work hard, find the education we provide stimulating, make a valuable contribution to the extra-curricular life of the school and enjoy his time here. Hence I am delighted to offer [REDACTED] a Boarding place at St Paul's School starting in September 2022 to study Mathematics, Physics, Art and Further Mathematics.

Selecting [REDACTED] school at 16+ is an important decision and we realise that you may wish to find out more about our school. We would therefore like to invite you to either participate in a live stream on Tuesday, December 7 at 6 pm (GMT), or visit the school in person on Wednesday, December 8 at 9.30 am (GMT). Hopefully this will help you decide whether to accept our offer.

Both events will include talks from Sally-Anne Huang, High Master and Naomi McLaughlin, Undermaster - Head of Year 12. Students who previously joined at 16+ will also be in attendance. They will be happy to talk about their experiences of joining St Paul's and answer any questions you may have. The live stream will include a virtual school tour and a recording of the evening will be available after the event. If you are able to attend in person on the Wednesday, you will be taken on a tour of the school, led by a senior student who joined us at 16+. Please contact the Assistant Registrar, far@stpaulsschool.org.uk, by 4 pm on Friday, **December 3**, if you would like to attend either of these events.

In the Spring we will send you the final details of courses which will be offered in the Autumn of 2022. It will be possible for [REDACTED] to change his current choice of subjects, however, we would need to consider his suitability to begin different courses in September and may request he achieves subject specific target grades in Summer examinations.

[REDACTED] place is conditional upon him achieving the following grades at IGCSE: at least eight passes including English and Mathematics. Of these he will need to achieve six IGCSEs at grade A*/8 or 9, no more than one at

grade B/6 and at least grade A/7 in the remaining subjects. We would expect [redacted] to achieve these grades to meet the conditions of the offer, if he does not reach the required standard, the acceptance deposit will be refunded.

If you decide to accept the offer, we have enclosed all the associated paperwork for your attention. We ask that you return the completed acceptance form and pay the acceptance deposit by Monday, 13 December, 2021. Details of how to pay the £3100 acceptance deposit can be found at the end of the acceptance form. For more details about the acceptance deposit and it how will be credited, please refer to Section 3.2 of the School's *Terms and Conditions*.

Once duly completed, signed and returned the acceptance form, this offer letter, the fees list and the School's *Terms and Conditions* form a legally binding contract between you and the School, which commences on the day we receive the form. The acceptance form draws upon many clauses in the School's *Terms and Conditions*, the *Behaviour, Rewards and Sanctions policy* and the *Fee List*. Copies of the current editions of these documents are included for you to read and keep. Please take time to study them carefully as they provide the framework, extent and limitations of our educational service, and our requirements from pupils and those with parental responsibility. If there are any details about the School or educational services that are important to you when deciding to accept this offer, please do let me know before you complete and return the acceptance form.

Please be aware that you may be required to provide further information when completing the acceptance form. For example, please enclose any recent SEND reports which we may not have already received.

If your child is not a British or Republic of Ireland citizen and the School is not sponsoring your child under a Child Student visa, then you must enclose evidence of your child's right to study in the UK.

Also attached is a supplementary information sheet requesting information on family connections to St Paul's Schools (SPS, SPJ and SPGS). Please provide details of UK based Educational Guardians if your son has one. Please also indicate if you want to register interest in a music scholarship.

Should you initially accept the offer of a place but at a later date wish to cancel it, the details and implications of this can be found in section 8 of the School's *Terms and Conditions*. Please write to the Admission Office informing us of your decision as soon as possible.

Our current fees list is enclosed with this letter. The fees list is updated annually and we will notify you of any changes. All families are eligible to apply for a means tested bursary, which is awarded after a full assessment of their income and assets. Details are provided on our website. If you feel you may qualify and wish to enquire, please email admissions@stpaulsschool.org.uk and we will arrange for our Finance Office to contact you. If your acceptance of the place is dependent on a bursary, please do not return the Acceptance Form and deposit until the assessment has been completed.
